Continuing Education Units (CEUs)



Revised CEU Requirements for CSAs

Beginning June 1st, 2019, individuals desiring to recertify by continuing education will be required to submit 38 CEUs during the 2-year recertification cycle. Of these, 8 CEUs must be derived from a live event, physically attended by the practitioner.

Current NSAA CEU Policy

The *Continuing Education Policies for the CSA* is provided for CSAs as participating in Continuing Education Units (CEU). CSAs as must adhere to these high standards, established by the profession to ensure the ongoing educational development of individual practitioners and to demonstrate to the public the profession's commitment to providing the highest level of quality surgical patient care. The National Surgical Assistant Association (NSAA) is recognized by the National Commission for the Certification of Surgical Assistants (NCCSA) as the responsible authority for the approval of CEU programs for the CSA, including responsibility for CEU credit processing and maintenance, which is subject to NCCSA audit or verification.
