### What is a Decompressive Craniectomy?

A decompressive craniectomy is brain surgery that removes a portion of the skull. When the brain swells following an injury, the pressure in the brain can build inside the skull, causing further damage. The body's natural healing response to injury is to swell. Swelling in the brain, however, can be dangerous because the skull restricts the swelling and pushes on the



Fast facts on decompressive craniectomy:

- Injury can cause dangerous pressure in the brain that increases blood pressure, slows blood flow, and damages the brain.
- In some cases, brain swelling can cause fatal injuries.
- A decompressive craniectomy involves removing part of the skull to reduce pressure in the brain.
- A large number of people who undergo decompressive craniectomy still die from brain swelling, despite the surgery.

## The Bureau of Labor Statistics has approved for 2018 a separate definition for Surgical Assistants.

*This is the accepted definition as it is listed:*

*29-9093 Surgical Assistants Assist in operations, under the supervision of surgeons. May, in accordance with State laws, help surgeons to make incisions and close surgical sites, manipulate or remove tissues, implant surgical devices or drains, suction the surgical site, place catheters, clamp or cauterize vessels or tissue, and apply dressings to surgical site. Excludes "Registered Nurses" (29-1141) and "Surgical Technologists" (29-2055)*

## Hammer toe surgery: What to expect

A hammer toe is a potentially painful deformity of the second, third, or fourth toes, where the toe bends upward at the joint, resembling a hammer.

When a hammer toe causes pain, and other treatments fail, surgery may be the only option for correcting the joint.



A hammer toe causes the toe to bend at the first joint, which is called the proximal interphalangeal joint. The problem usually begins with a muscle imbalance. When a muscle gets too weak, it can put pressure on the tendons of the toe. This can eventually cause the joint to become deformed.

People with hammer toe may also develop corns or calluses at the top of the joint from the toe rubbing on poorly fitted shoes. Wearing ill-fitting or pointy-toed shoes is one of the most common causes of a hammer toe. High heels can also cause the condition, because the heel pushes the front of the foot down, forward, and against the shoe. Over time, the toe muscles grow weaker and are no longer able to straighten the toe.

### Submitting CEUs

CSAs must recertify every 2 years. Part of the recertification requirement is to submit 50 continuing education units (CEUs) within those 2 years. CEUs need to be received by the NSAA 30 days prior to your certification expiration date to provide enough time for verification and processing, and for NCCSA to process your CSA recertification certificate. NSAA will send out emails to its members 60 days prior to your expiration date as a reminder. Please check your email spam settings to ensure that you are able to receive emails from info@nsaa.net.

### Checking CEU Status

You can check where you stand with your CEU count in the members area section of the website. Go to [www.nsaa.net](http://www.nsaa.net) and click on 'members area' at the top and log-in. If you have trouble logging in please call the office at 855-270-6722. This is a great way to know how many CEUs you have on file at any given time. This information is updated about 72 hours after CEUs are submitted to NSAA. Once you submit CEUs, we encourage you to check your member profile to ensure your CEUs were properly received and recorded.
